## SUB:- CLARIFICATIONS REGARDING CONFORMITY ASSESSMENT - ACCREDITATION

Dear Sir/Madam,

We are pleased to introduce ourselves as an international, independent, impartial, non-governmental accreditation body. The Accreditation Commission for Conformity Assessment Bodies (ACCAB) is a trading name for Accreditation Commission For conformity Assessment Bodies Private Limited a company limited by shares established in terms of Companies Act, 1956, Republic of India.

ACCAB operates in accordance with the requirements, criteria, rules and regulations laid down in the following documents:

- The requirements of the international standard ISO/IEC 17011, General requirements for bodies providing assessments and accreditation of conformity assessment bodies
- The requirements and other benchmarks as stipulated in the Publicly Available Documents (PAD) published by various international bodies and ACCAB
- Legally established objects as per Memorandum & Articles of Association with the Ministry of Corporate Affairs, Government of India.

The Board of Director has overall authority and responsibilities for policies and procedures for the operations of ACCAB. The Board delegates to the Chief Executive Officer (CEO) of ACCAB the responsibility to implement the ACCAB policies and procedures. Accreditation Approval Committees make decisions concerning the granting and continuation of accreditation. An independent Impartiality Committee representing the broad range of stakeholders reviews and adjudicates on possible conflicts of interest. The authority vested is ACCAB is that assigned to them by the Conformity Assessment Bodies and other Organization it accredits and recognizes by virtue of these applicant and accredited bodies pledging support for the mission and objectives of ACCAB and ensuring that their actions are according to that policy. The ACCAB started operating from September 2010. Please check our website www.accab.org for further details on us.

We would be highly obliged if you could give certain clarifications to the following points/issues which we came across in the initial stages of establishing our accreditation services as many stakeholders enquire with us regarding our position with the ILAC.

- 1. Has ILAC received any exclusive/nonexclusive legal mandate/recognition from any Government to operate its scheme for the accreditation bodies?
- ILAC is not a government body and therefore there is no government mandate as such to operate the ILAC MRA. There are now many governments around the world referencing the need for calibration and testing work to be carried out by laboratories accredited by the signatories to the ILAC MRA. Some examples of these are included in the Success Stories on the ILAC website <a href="http://www.ilac.org/successstories.html">http://www.ilac.org/successstories.html</a> In addition the Accreditation Facts page of the website highlights the increased regulator recognition of the use of the ILAC MRA at <a href="http://www.ilac.org/facts">http://www.ilac.org/facts</a> fig.html
- 2. Has any Government legislated that the all laboratories / Inspection Bodies are required to be accredited by ILAC Accreditation Body Members?

Yes, there are examples in many economies of governments regulating that laboratories must be accredited. This usually occurs within specific sectors, eg food, medical, electrical, etc testing.

- 3. According to ILAC, is it mandatory/ necessary for an accreditation body to be a member of International Laboratories Accreditation Corporation?
- ILAC does not mandate membership. Membership of ILAC is voluntary.
- 4. Are we officially permitted to use ILAC publications/guidelines/practices for the benefit of conformity assessment stakeholders, even though currently we are not a member of ILAC? Yes, you can seek permission, as per the copyright statement included in the ILAC publications, for the use of the ILAC publications. This permission is generally granted regardless of whether the organisation is a member of ILAC or not.
- 5. National Accreditation Board for Laboratories (NABL), India is already a member of ILAC. Would this situation restrict ILAC to accept any other Accreditation Body such as ACCAB from India for its membership?

No, the ILAC Rules do not restrict the number of accreditation bodies that can be members from one economy. You will see several examples in the membership list, ordered by economy, of economies with multiple accreditation bodies as members of ILAC. Some examples include USA, Japan and Thailand. 6. What is the route for ACCAB to become a member of ILAC?

I am not sure if you have reviewed the membership criteria for ILAC membership available from

http://www.ilac.org/membershicriteria.html As you will see, at this stage, I imagine ACCAB will be interested in either Affiliate or Associate membership of ILAC at this stage. Once you advise on the level of membership ACCAB is interested in, I will be able to advise on the process for membership and the fees associated with that level membership. In general there are no application fees for membership of ILAC, there are however annual membership fees for which the members are invoiced every January. As soon as you
