
ACCAB operates VOLUNTARY Accreditation Programs for the Management System Certification Bodies according to the International Standard such as ISO/IEC 17021:2011.

As per the Completion Appellate Tribunal (India) Order dated 17th January 2014:


- 1. Accreditation business is international and there are already several international bodies operating in India;
- 2. Accreditation Bodies are not required to be covered under any network of law and are free to grant certificates of accreditation to the laboratories in India, this also means that ACCAB does not require any permission, sanction or approval of any ministry / government department / agency to operate as an independent accreditation body;
- 3. All the government notifications were prior to the business set up by ACCAB, and even in these notifications it is suggested that any other accreditation body comparable were acceptable to the government companies;
- 4. No Accreditation Body enjoy the monopolistic position as accreditation bodies in India as they have no objection or have not indulged in activity to keep any competitors out of the market. And any-body including ACCAB would have an authority to act as the accrediting body provided such body has the necessary infrastructure.
